Vice Chairwoman Yvonne Nirelli called the meeting to order at 11:35 a.m. via Zoom video conference.

Approve Minutes:

The minutes of the July 16, 2020 meeting were unanimously approved on the motion of Supervisor Bono and second of Supervisor Stokes.

Purchasing:

Purchasing Agent Laurie Winters informed the Committee that PCard activity rebate cycle ends this month and we met the goal for \$1.1% rebate. They are currently working on the elevator bid and there will be two bids in October for federally funded bridge projects. A resolution has been submitted to piggyback on Onondaga County's bid for Industrial Laundry Service through Unifirst Corporation, which came in less than the previous two years.

Board of Elections:

Elections Commissioners Mary Egger and Laura Costello submitted a resolution to the Committee to renew leases for pollsite buildings. They have the funds to cover the costs for poll pads so a transfer is not necessary. Governor Cuomo is expected to make an announcement regarding elections today, perhaps allowing the use of COVID-19 as an excuse for absentee ballots.

Authorizing the Chairman to enter into an agreement with Unifirst Corporation and awarding piggybacking of Onondaga County Bid0010436 to provide Industrial Laundry Service
