In compliance with Executive Order 202.61, voters in Madison County may drop off completed absentee ballots at the Board of Elections and Early Voting site, both located at 138 North Court St, Building #4, Wampsville, NY 13163. The ballot drop-off will be clearly marked at the entrance of each. On Election Day voted absentee ballots may be dropped off at any Madison County pollsites. All pollsites will have a separate, clearly marked table where voters can deliver the ballots. Signage at the entrance to the polling place will direct the voter to the ballot drop off, avoiding any lines or delays. All ballots will be secured in a sealed ballot bag until they are delivered to the Board of Elections office to be received.
