**COUNTY OF MADISON  
PROPOSED LOCAL LAW FOR THE YEAR 2020**

**A LOCAL LAW SUPERSEDING PUBLIC OFFICERS LAW SECTION 3(1) AS TO THE  
RESIDENCY OF A CERTAIN PUBLIC OFFICER OF MADISON COUNTY**

Be it enacted by the Board of Supervisors of the County of Madison as follows:

**SECTION 1: LEGISLATIVE INTENT**

The Board of Supervisor hereby finds that because of her expertise and years of experience in the Madison County Department of Social Services, it is in the public interest that Jesica L. Prievo be promoted to the title of Deputy Commissioner for Family Services. The Board of Supervisors hereby finds that requiring Jesica L. Prievo to move from her current residence in an adjoining county is not required given such expertise and experience, and accordingly an exemption from the residency requirements ordinarily applicable is warranted.

**SECTION 2: EXEMPTION**

The provisions of Public Officers Law Section 3(1) requiring public officers employed by Madison County to be residents of Madison County shall not prevent Jesica L. Prievo from holding the appointed county officer's position of Deputy Commissioner for Family Services in Madison County, provided that such person resides in an adjoining county in the State of New York. The provisions of Public Officers Law Section 3(1) to the contrary are hereby superseded.

**SECTION 3: SEPARABILITY**

In any clause, sentence, paragraph or section of this local law shall be adjudged by any court of competent jurisdiction to be invalid, such judgment shall not impair or invalidate the remainder hereof, but shall be confined in its operation to the clause sentence, paragraph, or section directly involved in the controversy in which judgment shall have been rendered.

**SECTION 4: EFFECTIVE DATE**

This local shall take effect immediately upon filing in the office of the secretary of state pursuant to Municipal Home Rule Law Section 27.
