**Resolution #62-2022** Authorizes The Purchase of a 1987 Marklift Hydraulic Manlift in Conjunction with The Town of Smithfield and The Town of Lincoln

WHEREAS, the Town of Cazenovia Highway Department owns a 1987 Marklift Hydraulic Manlift (Serial Number: 489M3922); and

WHEREAS, the Town of Smithfield Highway Superintendent of Highways has previously advised the Town Board of the Town of Smithfield of it's need for such a piece of equipment; and

WHEREAS, the Towns of Smithfield and Lincoln have offered to purchase said manlift from the Town of Cazenovia Highway Department for Four Thousand and 00/100 Dollars (\$4,000.00); and

WHEREAS, the Town Board has determined to be a reasonable and best price to obtain a piece of equipment of this nature.

NOW, THEREFORE, IT IS

RESOLVED AND DETERMINED, that this Board authorizes the Town of Smithfield Highway Superintendent of Highways to purchase aforementioned equipment in conjunction with the Town of Lincoln Highway Department, as is, without any warranties, expressed or implied, for a purchase price of Four Thousand and 00/100 Dollars (\$4,000.00); and it is further

RESOLVED AND DETERMINED, that the Town of Smithfield Superintendent of Highways is hereby authorized to sign any papers and take all actions to give full force and effect to this resolution and it is further

RESOLVED AND DETERMINED, that the funds for said purchase shall be used from the appropriate Town of Smithfield Highway Fund, DA5130.2, in accordance with appropriated funds for said account in the Town of Smithfield adopted 2022 budget.
