PROPOSED LOCAL LAW

**A LOCAL LAW RESCINDING LOCAL LAW NO. 4 OF THE YEAR 2018
RELATING TO THE OVERRIDE OF THE TAX LEVY LIMIT FOR FISCAL
YEAR 2019 PURSUANT TO GENERAL MUNICIPAL LAW §3-c**

IT IS HEREBY ENACTED by the Madison County Board of Supervisors as follows:

SECTION 1.: TITLE.

This local law shall be known and cited as "Madison County Local Law No. 6 of the Year 2018 Rescinding Local Law No. 4 of the Year 2018 Overriding the Tax Levy Limit for Fiscal Year 2019 pursuant to General Municipal Law §3-c".

SECTION 2.: LEGISLATIVE INTENT.

The Madison County Board of Supervisors, by Resolution No. 18-359 adopted Local Law No.4 of 2018 which Local Law overrode the tax levy limit for fiscal year 2019 pursuant to General Municipal Law §3-c. This Local Law was enacted as a precautionary measure. The Board of Supervisors has determined that as a result of the 2018 budget process the budget for 2019 will be kept within the tax levy limit as provided in General Municipal Law §3-c.

SECTION 3.: AUTHORITY

This local law is adopted pursuant to General Municipal Law §3-c and to the provisions of the Municipal Home Rule Law.

SECTION 4.: RESCISSION OF LOCAL LAW NO. 4 OF 2018

Local Law No. 4 of 2018 adopted on September 11, 2018, by Resolution No.18-359 and filed in the office of the Department of State on September 19, 2018 hereby is rescinded.

SECTION 6.: EFFECTIVE DATE.

This Local Law shall take effect immediately upon filing in the Office of the New York State Department of State in accordance with §27 of the Municipal Home Rule.


