

Calendar for June Village Elections June 21, 2016

March 7	First day to sign party designating petitions.
April 5	First day to sign independent nominating petitions.
April 11 - 18	Dates for filing party designating petitions.
April 12 - 26	Dates to publish notice of party caucus in newspaper. (Not earlier than 2 weeks before caucus or later than 1 week before caucus)
April 18 - 25	Last day to post & file notice of party caucus with the village clerk & county board of elections. (At least 10 days before caucus)
April 16 - 23	Dates to post notice of party caucus in 6 public places. (At least 10 days before caucus)
April 26 – May 3	Dates for holding a party caucus.
April 28 – May 5	Dates for filing certificate of party nomination.
May 3	Village Primary Day (if necessary)
May 10 - 17	Dates for filing independent nominating petitions.
June 10	Last day to register with the county board of elections to be eligible to vote in the village election.
June 21	Election Day – polls open noon to 9pm
June 22	Board of Elections canvass/certify results.

Registration by Mail: Forms for Registration by mail may be obtained at the Board of Elections or downloaded at www.madisoncounty.ny.gov/boe

Forms are also available at the Post Office and the Village and Town Clerk’s offices. The registration must be received at the Board of Elections by June 10, 2016.

Absentee Voting: If a qualified voter will be absent from Madison County on Election Day, absentee ballots are available. An absentee application (available at the website or by calling the Board of Elections) must be on file at the BOE before a ballot is mailed to the voter. Absentee ballots for a Village Election must be postmarked by the day before the Election and received by 9pm Election Day.

Financial Disclosure Filing Dates:

May 20	(32 days before election)
June 10	(11 days before election)
July 18	(27 days after election)

Candidates spending or receiving over \$1,000 are required to file the financial disclosure reports (dates above) and register with the State Board of Elections. Village candidates spending or receiving less than \$1,000 will file a **CF-05** (Claim of Exemption) with the County Board of Elections. Please contact the Board of Elections for filing information.
