Madison County is committed to protecting the environment

Madison County's recycling program began in 1990. Since its inception, the recycling program has grown dramatically.

New items are continually being added to the growing list of recyclables and every effort has been made to simplify the recycling process. The County's recycling program has succeeded because of resident participation and an effective and steadfast recycling education program.

Protecting our environment is a big task but when everyone works together toward a common goal, the task becomes easier. One person can make a big difference when it comes to saving our environment.

Recycling education and promotion is an integral part of the County's Solid Waste Management Plan (SWMP). Many of the County's recycling programs are part of the Solid Waste Management Plan and are funded in part through grants received from the New York State Department of Environmental Conservation (NYSDEC).

Numerous items have been added to the recyclable list over the past 25 years. Some of these items are: computer monitors and televisions, pizza boxes, inkjet and laser cartridges, cooking oil, stackable plastic containers and plastic retail bags. New endeavors include the safe collection of prescription and over the counter medications and free shredding events; both are held biannually. In 2011 pots & pans were added to the curbside recycling list.

New recyclable items are promoted through aggressive media campaigns in the local newspapers and on radio and television. Information regarding what can be recycled in Madison County can also be found in fliers and brochures available at all town and village clerks' offices, area libraries and from the landfill office. Recycling and landfill disposal information can also be found on the County web site www.madisoncounty.ny.gov

The County has produced this booklet combining numerous recycling fliers and brochures along with the County's updated Recycling Guide and the Madison County Landfill Regulations and fee schedule for County residents.

Recycling education plays an important role in the overall operation of the Madison County Landfill. Visitors from throughout the county and beyond tour the landfill and recycling center each year. The Recycling Coordinator conducts tours for area grade schools, colleges and community groups. In any given year, the Recycling Coordinator conducts landfill and recycling center tours and puts on recycling presentations for between 1,500 to 2,000 people.

Recycling saves space in the landfill by cutting down on the waste stream. Less energy is needed to make new products from recycled material. Reduce, Reuse, Recycle are the preferred waste management options, along with composting because they reduce the amount of waste going to the landfill and conserve natural resources and energy.

Involving your youngster (s) in the daily recycling routine in your home helps to reinforce the Reduce, Reuse and Recycle concept.



Our Volunteer Program Cooking Oil - Recycling for Madison County Residents

Madison County residents can now recycle liquid cooking oil and grease from deep fryers **FREE OF CHARGE.**



To dispose of used cooking oil bring it to the Buyea Rd. Transfer Station in the Town of Lincoln. The attendant will assist residents with their containers of used cooking oil. The cooking oil recycling program is for residential customers only and includes only liquid cooking grade fats, oils and grease - **NOT** petroleum products.

Madison County offers a number of specialized recycling programs for the convenience of its residents.

Madison County continues to be a leader in solid waste management in New York State, thanks to you: the good citizens of Madison County.

The following items are accepted at county transfer stations in the Towns of Cazenovia, Hamilton and Sullivan, and at the County Landfill in the Town of Lincoln except where indicated.

- ✓ Aerosol cans - must be empty
 - ✓ Agricultural plastic - bundle neatly
 - ✓ Antifreeze* limit 5 gallons per drop off
 - ✓ Batteries - household & vehicle (Please do not put batteries in with your recyclables or trash. Use the Madison County Household Battery Collection bags and give to your hauler or transfer station attendant. Battery Bags are available at the County, Village, Town and City offices in Madison County.)
 - ✓ Cell Phones - no charge
 - ✓ Clear Plastic Bags - no charge
 - ✓ Cooking oil & grease* - no charge
 - ✓ Computer monitors & Televisions
 - ✓ Containers: plastic 1 - 7, cans, returnables, glass jars - no charge
 - ✓ Glass: windows or auto glass, ceramic, crystal and mirrors - wrap in newspaper and give to attendant, or hauler.
 - ✓ Household Hazardous Waste: special regulations apply. go to www.madisoncounty.ny.gov/solidwaste click on Household Hazardous Waste for disposal instructions
 - ✓ Ink Jet Cartridges - no charge
 - ✓ Items containing mercury: CFL light bulbs, thermostats, thermometers - wrap in original packaging or newspaper, give to attendant - no charge
 - ✓ Propane tanks* 20 lbs and larger, must be empty. - Note: small 'Coleman-type' propane cylinders are NOT recyclable. They go in the garbage, must be empty.
 - ✓ Pots & pans - put in with containers - no charge
 - ✓ Refrigeration Units*
 - ✓ Scrap Metal - no charge
 - ✓ Used motor oil - no charge (limit 5 gals. per drop off)
 - ✓ Textiles: clothing, shoes, blankets, sheets, sleeping bags, belts etc. must be clean and dry - no charge **NO RUGS OR CARPETS**
 - ✓ Tires *
 - ✓ White goods: washers stoves, water heaters - no charge
 - ✓ Yard Waste: ** grass clippings, leaves, weeds, branches up to 6 inches diameter - take to compost area
- * Only accepted at the Buyea Rd. landfill site.
 ** As part of a successful program, residents are welcome to take composted materials free of charge from the three county transfer stations and the landfill (when available).

Special Program

Madison County's Household Hazardous Waste Disposal is Fast and Easy and FREE

If you have Internet access, go to madisoncounty.ny.gov/hwf. Fill out the form and press the submit button. **DONE!**

You will receive an e-mail response, generally, within five working days. Download your information packet that includes a map and your appointment date. Take all paperwork with you to the appointment. Your destination is Environmental Products and Services on Hiawatha Blvd. In Syracuse - just down the street from Desinty USA., 8 a.m. - 5 p.m.

If you do not have internet access - call the Solid Waste Hotline at 1-800-721-2208 and request a Household Hazardous Waste appointment form. This method takes longer, but works just as well.

Madison County residents can dispose of 14 wet gallons and 20 dry pounds of household hazardous waste for free - yes, that is right - for FREE, five days a week all year long!

LANDFILL REGULATIONS

*The term Residential Waste shall mean solid waste generated from all houses, apartments and other residential dwellings, including, but not limited to, all single family dwellings and multifamily dwellings in Madison County in which you reside.

Residential Waste Permit requirements are as follows:

- a. Residential individuals collecting, transporting or disposing of their own Solid Waste and/or Recyclables will be required to obtain a Resident Waste permit at the transfer stations, landfill site and landfill office only at no charge. Such permit shall be displayed on a window of the delivery vehicle and shall be valid for the duration of the residence of such individual, or ownership of such vehicle by such individual, whichever is shorter.
 - b. Resident Waste Permits shall be available and are required for passenger cars, vans, station wagons and pickup trucks (up to 1-ton Capacity). All other vehicles must be registered under the provisions applicable to a Commercial Waste Permit or Special Waste Permit. The Department, at its sole discretion, may require any vehicles, regardless of type or size, transporting Solid Waste and/or Recyclable for compensation paid to the owner or operator, to comply with the provisions applicable to a Commercial Waste Permit or Special Waste Permit.
 - c. Residential Waste permit holders shall strictly comply with all rules and regulations prescribed by the Department.
- * All material must be source separated per County Recycling Law.
 - * All refuse and recyclables deposited in plastic bags must be in clear plastic bags.
 - * Asbestos, hazardous waste (as defined by NYS and Federal Regulations), liquids (including motor oil, and wet cell batteries) are prohibited. Ask attendant about recycling of wet cell (auto) batteries, motor oil, and automotive antifreeze.
 - * Hot ashes are prohibited.
 - * Yard waste can be recycled (grass, leaves, branches, etc.) at all four facilities. See attendant.
 - * It is illegal to remove any waste material or items from the transfer stations or landfill.
 - * The importation (from another county) of solid waste for the purpose of disposal within Madison County is strictly prohibited.
 - * Violation of any rule or regulation may result in fines and/or restricted use of the facility.
 - * All vehicles used in the collection, transportation, and/or disposal of Solid Waste and/or Recyclables must be constructed as to prevent leakage in transit. The vehicle must be wholly enclosed or shall be kept covered with an adequate cover. Operation of vehicles shall be done in such a manner as to prevent spilling or loss of contents. Fines will be issued for loads not adequately covered per Local Law No. 3 of 2004.



Plastic Retail Bag Recycling

Plastic retail bags are recyclable in Madison County. Plastic bags that can be recycled include, but are not limited to retail, grocery, dry cleaning and newspaper bags. To recycle place clean plastic retail bags inside each other, tie a knot in the top when full and place the plastic bags out at curbside with newspapers and cardboard.



A second option is to drop off plastic bags at any of the County's transfer stations.

Do NOT include the following, as they are considered contaminants:

- * NO Food Wrap (e.g., Saran Wrap®)
- * NO Bags that have had direct contact with food
- * NO Bags that have been painted or glued

KEEP TRASH IN YOUR TRUCK BED... SECURE YOUR LOAD

Many taxpayer dollars are spent each year to remove trash that blows from truck beds and car trunks. Transporting unsecured loads is illegal in Madison County.

Tarp It, or Get Ticketed!



Madison County law can impose fines for hauling an improperly secured load. Penalties may reach up to a \$2,000 fine.

LITTER. It costs you.

Put a Lid on It!

All of us share a responsibility to Keep Madison County Beautiful. You may not intentionally litter, but if you're not securing the items in your open car trunk or pickup truck, they could easily become litter.

Take the time to secure your load.

Don't rely on the weight of items to keep them in your truck or trunk of your car. Bumps, turns and sudden stops can dislodge even heavy items like furniture, tools, and equipment. **All trash or recyclables should be in sturdy bags and covered by a strong tarp or cargo netting.**

It doesn't take much time, effort, or money to make sure your load is properly secured.

Commercial garbage and recycling haulers aren't to blame for all of the trash that turns into litter. In fact, most in the industry say the small haulers, especially, weekend warriors cleaning out the garage or hauling home remodeling debris share the responsibility. It doesn't take long to secure a tarp or cargo netting over a pickup truck bed or trunk of your car. Tarps can be bought for under \$20, including tie-downs, at most home improvement or automotive stores.


A FREE PROGRAM FOR RESIDENTS OF MADISON COUNTY

When preparing bulbs for disposal place tubes back in original sleeve or box or in the sleeve the replacement tube came in. CFL's (spiral bulbs) should be wrapped in one sheet of newspaper and then placed in specially marked containers at the Buyea Rd. transfer station. Mercury containing thermostats should be wrapped in newspaper and given to the transfer station attendant. If you have questions ask the transfer station attendant. 
OF OLD POTS & PANS

Don't know what to do with your old and unusable metal pots and pans? Recycle them.

Madison County is adding pots and pans to the list of voluntary recyclable items. Pots and pans can be placed at curbside along with recycled steel and aluminum cans, or recycled at the transfer stations.

Metal cookware is by no means the biggest culprit when it comes to mine-waste problems. However, taken together, the extraction and processing of all metals creates between 1 and 2 billion tons of mine waste annually, and has polluted more than 3,400 miles of streams and more than 440,000 acres of land.

In 2004, the US Environmental Protection Agency (EPA) ranked the metal mining industry as the nation's worst toxic polluter.

Proper disposal of medical syringes at home can prevent injury, illness, and pollution.

Madison County's Safe Syringe Disposal Program makes syringe disposal easy and safe by providing special plastic containers for disposal of used medical syringes and convenient drop off sites that are strategically located throughout Madison County.

Place: New or Used Needles, Syringes & Lancets in Madison County's free, red, puncture-resistant containers.

Do Not: use any other container to dispose of your sharps.

Do Not: place loose syringes in the new drop off containers.

Do Not: throw used medical syringes in the garbage.

Do not put Syringes in recyclable containers.

How to use your red container

1. Do not cap, remove or bend needles.
2. Drop used syringe, with needle pointing down, into container.
3. Do not overfill container.
4. Keep container out of reach of children and pets.
5. When full, close and seal container, then dispose of it in the convenient drop boxes located at all county transfer station sites



HOW IT WORKS

- Collect & store your agricultural plastics at your farm
- Store as listed on the right
- Drop off at the Buyea Landfill for **FREE**

WHY RECYCLE AG PLASTICS

- Save money on your farm waste costs-- it's **FREE**
- Help the environment by keeping plastic out of landfills

BROUGHT TO YOU BY:



MULCH & THIN FILMS

- Cut into pieces
- Brush or shake to remove debris
- Roll and fold dry films into bundles



Sample Bundles

HIGH TUNNELS & HOOPHOUSE COVERS

- Cut into small sections
- Dimensions will depend on thickness and flexibility of film

RIGID PLASTIC POTS, CONTAINERS, DRIP TAPE & TRAYS

- **Stack Pots & Trays:** Knock out loose soil.
- Keep dry. Tie onto pallet.

STORING PLASTIC

- **Store Under Cover:** Keep as clean and dry as possible—e.g., store on pallets in a barn, trailer, hay wagon or outside under a tarp.
- **Do not mix different types of products**
- Separate clean films from dirtier. No PVC accepted.
