

MADISON COUNTY BOARD OF SUPERVISORS
2nd Day of Annual Session – Tuesday, November 17, 2009

The Board re-convened at 9:05 a.m. in the Supervisors Chambers, second floor, County Office Building, Wampsville, New York with all members present except for Supervisor Jaquay (129 votes), Supervisor Bargabos (27 votes) and Supervisor Stepanski (47 votes).

Pledge of Allegiance.

Chairman Becker announced the scheduled public hearing on the 2010 Cazenovia Sewer District budget. Supervisor Williams made a motion to open the hearing, seconded by Supervisor Degear and carried. Chairman Becker then asked for speakers:

Mark Bourdeau, Chief Operator from the Cazenovia Sewer District addressed the Board stating that the Sewer District held an informational meeting on their budget on November 18th, with no opposition and no tax rate increase. He urged the Board of Supervisors to adopt the Sewer District budget.

There being no other speakers, Chairman Becker asked for a motion to close the hearing. Supervisor Salka made that motion, seconded by Supervisor Reinhardt and carried.

Chairman Becker then announced the scheduled public hearing on the 2010 Cowaselon Watershed District budget for 2010. Supervisor Degear made a motion to open the hearing, seconded by Supervisor Henderson and carried. Chairman Becker then asked for speakers. There being no speakers, Supervisor Moran made a motion to close, seconded by Supervisor Rafte and carried.

Chairman Becker then announced the scheduled public hearing on the 2010 Tentative County budget. Supervisor Salka made a motion to open the hearing, seconded by Supervisor Degear and carried. Chairman Becker then asked for speakers to the budget:

1. Becca B.R. Jablonski – Agriculture Specialist for the Agriculture Economic Development Program spoke and urged the Board to put funding back in the 2010 budget for a part-time position.
2. Steve Durfee, a local farmer and a member of the AED Committee also spoke urging the Board to reinstate funding for a staff person with the AED program.
3. Paul O'Mara, a member of the AED Committee also asked to Board to reinstate funding the part-time position in the AED program. Becca has outdone all expectations, but help is needed. This little amount of funding can bring big results to our county.

Several Supervisors had questions about the program that Becca addressed. There being no other speakers Supervisor Williams made a motion to recess the hearing, seconded by Supervisor Cary and carried.

On motion by Supervisor Rafte, seconded by Supervisor Hammond the minutes of the previous meeting were dispensed with and adopted as filed.

(NEW) GOVERNMENT OPERATIONS: responsible for Personnel, Civil Service, Labor Relations, Insurance, County Attorney, Ethics Law, Office of the Clerk to the Board of Supervisors, Receptionist, Supervisors' Accounts, Official Papers, Supervisors' Journal, NYSAC, Public Relations to include Freedom of Information Law and Records Access Officer, OSHA, ADA, HIPAA, Safety and Workers Compensation, Employees Assistance Program, Weights and Measures, Personnel Management Functions, participate in the interview process for new Department Heads with the respective legislative committee and to recommend to the Board the names of candidates for all county management positions, Purchasing and Information Technology.

At this time Chairman Becker gave a presentation pointing to prepared charts showing proposed tax rates in Madison County for 2010. He showed that the Supervisors 3% raise in salary would have no affect on the tax levy; which was a concern among several Supervisors. Chairman Becker emphasized that it's the State officials handing down unfunded mandates and other costs onto county's that is the real budget issue here.

The Board stands recessed until 7:00 p.m. tonight.

The Board reconvened at 7:00 p.m. with all members present except for Supervisor Hammond (21 votes), Supervisor Jaquay (129 votes), Supervisor Williams (44 votes) and Supervisor Bargabos (27 votes). Also in attendance were the Perryville Troop 107 Boy Scouts, some department heads and a handful of residents.

Pledge of Allegiance.

Employee Ann Jones and member of the EAP Program was given permission to address the Board to talk about the County's EAP – Employee Assistance

Program; the many benefits and how it can help employees in time of need. She also announced the 2nd Annual Employees Art Show scheduled for November 30th - December 4th here on the county complex.

Chairman Becker announced the scheduled public hearing on the tentative county budget for 2010.

Supervisor Ball made a motion to open the hearing, seconded by Supervisor Rafte and carried.

The following people spoke:

1. Becca B.R. Jablonski, Agriculture Specialist for the Agriculture Economic Development Program, who spoke earlier today, asked the Board to reconsider adding funds for administrative support to that program, asked permission for two people to speak at tonight's hearing.

Abner Glick from the Smithfield Township stated that he came to this area and started a slaughter business, but was shut down due to violations with USDA codes and regulations. It was through the help of Becca that he was able to work out those problems and reopen his business. He asked the Board to reconsider adding these funds back into the budget.

Daniel Kline, a local farmer in the area stated that Madison Bounty, a program through the Cooperative Extension headed up by Becca has helped make his business a success. He also asked that funding for support services be reinstated in the 2010 budget.

There being no further speakers, Supervisor Degear made a motion to close the hearing, seconded by Supervisor Stepanski and carried.
