SECTION 1. Local Law #2 of 2013 amending Local Law #2 of 2010 amending Local Law # 4 of 2008 is hereby amended to read as follows:

Section 2. The position shall be filled by the appointment of the Madison County Board of Supervisors. The term of office for the County Administrator shall be for a period of four years. The next term to expire or December 31, 2016. Appointment to fill a vacancy in the Office of County Administrator shall be for the remainder of the unexpired term.

SECTION 2. This amendment to Local Law No. 2 of 2010 amending Local Law No. 4 of 2008 shall be effective immediately.
