CREATING A TEMPORARY VEGETATION HARVESTER OPERATOR POSITION IN THE PLANNING DEPARTMENT

WHEREAS, Madison County owns a mechanical vegetation harvester and related equipment, which were purchased in 2003 with State grant funds; and

WHEREAS, numerous lakes within Madison County have again expressed interest in benefiting from the weed harvester this summer; and

WHEREAS, Madison County can provide this service to lake associations at the very economical cost of \$31/hour; and

WHEREAS, this request has been reviewed and approved in accordance with the vacancy review procedure by the Planning, Economic Development, Environmental and Intergovernmental Affairs Committee and the Government Operations Committee,

NOW, THEREFORE BE IT RESOLVED that one (1) temporary full-time Vegetation Harvester Operator position be and hereby is created for a period not to exceed fourteen (14) weeks from date of appointment; and

BE IT FURTHER RESOLVED that the Planning Department be and hereby is authorized to fill said position at the 2014 hourly rate of \$17.80 in accordance with Civil Service Law and Rule and County policies and procedures effective immediately.

CREATING ONE TEMPORARY POSITION IN THE PLANNING DEPARTMENT

WHEREAS, the Workforce Development Division of the Madison County Planning Department will operate a Workforce Investment Act and/or Temporary Assistance for Needy Families Summer Youth Employment Program during 2014, contingent on program funding; and

WHEREAS, this summer program may employ up to eighty (80) youths, ages 14-21 (age depends on the funding streams), which will require one (1) temporary Summer Youth Counselor position; and

WHEREAS, the wages and fringes for the Summer Youth Counselor position are one hundred percent (100%) federally funded under the WIA and TANF programs; and

WHEREAS, the Director of Planning certifies that no hiring will occur until official word of appropriation is received; and

WHEREAS, this request has been reviewed and approved in accordance with the vacancy review procedure and has been approved by the Planning, Economic Development, Environmental and Intergovernmental Affairs Committee and the Government Operations Committee;

NOW THEREFORE BE IT RESOLVED, that one (1) temporary full-time Summer Youth Counselor position be and hereby is created in the Workforce Development Division of the Planning Department contingent upon program funding, and

BE IT FURTHER RESOLVED, that the Director of Planning is hereby authorized to fill the position at a hire rate not to exceed \$11.00 per hour for the period June 9, 2014 through August 15, 2014, in accordance with Civil Service Law and Rule.

CREATING ONE TEMPORARY FULL-TIME POSITION IN THE SOLID WASTE DEPARTMENT

WHEREAS, Madison County Westside Landfill Cell 8 & 9 construction will commence in the spring of 2014; and

WHEREAS, the Director of Solid Waste Management has requested the creation of one temporary, full-time Heavy Equipment Operator position for this project; and

WHEREAS, the additional salary for said position will be funded from appropriations in the 2014 Solid Waste Department budget; and

WHEREAS, the Director of Solid Waste Management has evaluated the current staffing structure in the Department of Solid Waste and wishes to abolish four(4) Solid Waste Aide positions; and

WHEREAS, the Director of Solid Waste and Sanitation wishes to create four (4) Solid Waste Aide/Groundskeeper positions which will result in increased efficiencies in the department; and

WHEREAS, due to this restructuring, the total number of positions in the Department of Solid Waste will be maintained; and

WHEREAS, the Personnel Officer certifies that Solid Waste Aide/Groundskeeper is the appropriate classification based on the description of duties submitted for these positions; and

WHEREAS, this request has been reviewed and approved by the Solid Waste and Recycling Committee and the Government Operations Committee in accordance with the vacancy review procedure,

NOW, THEREFORE BE IT RESOLVED that four (4) part-time Solid Waste Aide positions be and hereby are abolished effective June 1, 2014; and

BE IT FURTHER RESOLVED that the new Solid Waste Aide/Groundskeeper title be and hereby is created June 2, 2014; and

AUTHORIZING THE CHAIRMAN TO ENTER AN AGREEMENT WITH TIME WARNER CABLE FOR HIGH SPEED INTERNET SERVICE AND MODIFYING THE 2014 ADOPTED BUDGET

WHEREAS, the use of the internet and electronic mail is becoming increasingly common and useful in government, information technology (IT) and business; and

WHEREAS, Madison County requires internet and electronic mail service to conduct research and maintain contact with numerous federal, state and local agencies and governments, private industry as well as our residents; and

WHEREAS, the nature of the information being transmitted and accessed often contains large files and complex documents; and

WHEREAS, the County needs to upgrade their internet connection to better accommodate new hosted software solutions and to potentially utilize an out of County disaster recovery system; and

WHEREAS, Time Warner Cable has submitted a proposal to upgrade the County's internet to a fiber connection that will provide virtually no downtime, is easier to connect to remote sites, and significantly increases upload speed; and

WHEREAS, the service is available from Time Warner Cable, a New York State Contract vendor, at a cost of \$1,303 per month with a one-time set up fee of \$500, for a term of five (5) years from the date of execution of the agreement; and

WHEREAS, the Government Operations Committee has reviewed and approved the agreement,

NOW THEREFORE BE IT RESOLVED, that the Chairman of the Board be and hereby is authorized to enter an agreement with Time Warner Cable of Syracuse, New York for high speed internet service, a copy of which is on file with the Clerk to the Board of Supervisors,

WHEREAS, most child protective services laws were enacted in the 1970s and have not been significantly amended since, including the failure to amend the law to keep up with the vast social and technological changes that have occurred; and

WHEREAS, Erie County is submitting to the New York State Legislature 19 pieces of proposed changes to those laws; and

WHEREAS, Madison County Department of Social Services would realize the most critical impact in keeping children safe in Erie County Bills numbered:

- 1 – (not yet introduced) Excessive Corporal Punishment
- 2 – (S.7060) Positive Toxicology
- 3 – (S.7062) Subpoena Records
- 4 – (S.7061) Criminal Records
- 8 – (S.7045) Endangering Welfare of Child: Class D Felony
- 11 – (S.7041) CONNECTIONS: Image & Document Storage
- 16 – (not yet introduced) Fatality Report Information; and

WHEREAS, the Madison County Board of Supervisors supports Erie County in their endeavor to amend the social services law and family court act;

NOW, THEREFORE BE IT RESOLVED, that the Madison County Board of Supervisors urges the Governor and State Legislature to amend legislation as requested by Erie County to improve the provision of child protective services to New York's children and families; and

BE IT FURTHER RESOLVED that the Madison County Board of Supervisors will forward copies of this resolution to Governor Andrew M. Cuomo; elected officials in the State Legislature, including Senator David Valesky and Assemblyman William Magee; and all others deemed necessary and proper.

AUTHORIZING THE CHAIRMAN TO APPLY FOR A BULLETPROOF VEST PARTNERSHIP PROGRAM FROM THE US DEPARTMENT OF JUSTICE

WHEREAS, the US Department of Justice has a Bulletproof Vest Partnership (FY2014 BVP) Program that reimburses body armor purchases that have a written mandatory wear policy for uniformed patrol officers; and

WHEREAS, the FY2014 BVP funds may only be used towards the purchase of vests ordered on or after April 1, 2014; and

WHEREAS, each vest purchased with FY2014 funds must meet National Institute of Justice Standards on the date it was ordered; and

WHEREAS, vests must be received and the request for payment submitted to the BVP system by August 31, 2016; and

WHEREAS, bulletproof vests expire after five (5) years and the application is being made for \$19,635.00 for the next two years; and

WHEREAS, as the US Department of Justice has a maximum allowable funding of 50% for BVP, the NYS Division of Criminal Justice Services will refund the remainder 50% of new vests for uniformed patrol officers; and

WHEREAS, the County will fund the remaining 50% of replacement vests purchased over the grant period; and

WHEREAS, this application has been reviewed and approved by the Criminal Justice, Public Safety and Telecommunications Committee; and

NOW, THEREFORE, BE IT RESOLVED, that the Chairman of the Board of Supervisors be and is hereby authorized to apply on behalf of the County of Madison with the US Department of Justice, in the form as is on file with the Clerk of the Board.

RESOLUTION NO. 144-14

AUTHORIZING THE CHAIRMAN TO ENTER INTO AN AGREEMENT WITH NEW YORK STATE OFFICE OF INDIGENT LEGAL SERVICES FOR A THREE-YEAR DISTRIBUTION 2014-2016

WHEREAS, the County of Madison by Resolution 251-12 dated August 14, 2012, entered into an agreement with the New York State Office of Indigent Legal Services for a Three-Year Distribution for June 1, 2012-May 31, 2015 (Grant #2);

WHEREAS, the County of Madison by Resolution 297-13 dated September 10, 2013, entered into an agreement with the New York State Office of Indigent Legal Services for a Three-Year Distribution for June 1, 2013-May 31, 2016 (Grant #3);

WHEREAS, the New York State Office of Indigent Legal Services and the County of Madison desire to enter into an agreement for the provision of funds to further assist the County in improving the quality of indigent legal services provided by such County pursuant to Article 18-B of the County Law for an additional Three-Year Distribution for January 1, 2014-December 31, 2016; and

WHEREAS, this Three-Year Distribution (Grant #4) will overlap with the 2012-2015 and 2013-2016 agreement;

WHEREAS, the maximum amount of funds available and payable to the County under this three-year distribution for 2014-2016 shall not exceed \$113,838; and

WHEREAS, the County shall be reimbursed only for costs actually incurred in accordance with this Agreement. WHEREAS, PAG Services, Inc. has projected 200-225 hours to complete the project,

RESOLUTION NO. 165-14

DECLARING “MAYDAY FOR MANDATE RELIEF”

WHEREAS, counties are mandated to administer and finance dozens of state and federal programs; and

WHEREAS, many counties in New York State face significant fiscal challenges made worse by the recent recession and slow economic recovery; and

WHEREAS, these county fiscal challenges are also directly tied to state-imposed mandates and in recent years reduced state reimbursement; and

WHEREAS, the New York State Association of Counties (NYSAC) has identified 9 state mandates that consume 90 percent of all county property taxes levied across the state (outside of New York City), representing over \$4 billion in county property taxes levied. These mandates include: Medicaid, Public Assistance Safety Net, Child Welfare Protective and Preventive Care, Special Education Pre-School, Early Intervention, Probation, Indigent Defense, Youth Detention, and Pensions; and

WHEREAS, these mandated and fixed employee costs can consume more than 80 percent of a county’s total budget, leaving fewer local dollars that can be devoted to local programs and services; and

WHEREAS, Medicaid alone accounts for over \$11 million (almost 40%) of the Madison County Tax Levy; and

WHEREAS, State mandates are the root cause of high county property and sales taxes in New York and have led to a decline in the delivery of important local services such as County road and bridge rehabilitation,

NOW, THEREFORE, BE IT RESOLVED, that Madison County hereby declares the month of May to be “Mayday for Mandate Relief” to raise awareness that decisions made in Albany have a direct impact on the property tax levy and local community services here in Madison County; and

BE IT FURTHER RESOLVED, that Madison County strongly encourages the Governor and State Legislature to continue working to enact meaningful mandate relief; and

BE IT FURTHER RESOLVED, that Madison County calls on State Lawmakers to enact legislation preventing future unfunded mandates without corresponding state aid to pay for them; and

BE IT FURTHER RESOLVED, the Clerk of the Board shall forward copies of this resolution to Governor Andrew M. Cuomo, the New York State Legislature and all others deemed necessary and proper.
