**AUTHORIZING THE CHAIRMAN TO RENEW AN AGREEMENT WITH
FAMILY COUNSELING SERVICES OF CORTLAND COUNTY, INC.**

WHEREAS, \$1.2 million in federal Child Abuse Prevention and Treatment Act (CAPTA) funds for Child Protective Services and behavioral health partnerships has been made available through a competitive grant application; and

WHEREAS, Madison County's application for funding has been approved by the New York State Office of Children and Family Services; and

WHEREAS, the primary goals of Child Protective Services are preserving families and protecting children; and

WHEREAS, counties were being asked to contract for behavioral health clinicians to work alongside Child Protective Services caseworkers in order to identify and support the behavioral health needs of both the adults and children in families involved in Child Protective Services; and

WHEREAS, Madison County identified a need for such services based on increased opiate abuse, prescription medication misuse, and ongoing alcohol and other substance mistreatment, along with mental health illness; and

WHEREAS, Family Counseling Services of Cortland County, Inc., (FCS) has been providing this service for co-location of a substance abuse/mental health clinician together with the Child Protective Services workers; and

WHEREAS, over the past year, this co-located therapist has provided services to approximately 70 families, working with 3 to 6 family members per case in providing screens or assessments for mental health and substance use disorders, short term interventions, or referrals for long term treatment; and

WHEREAS, the behavioral health specialist has assisted nearly 80 people in obtaining long-term services with 85-90 percent of those individuals making it to their first referral appointment; and

WHEREAS, Family Counseling Services of Cortland County, Inc., has agreed to provide this service for the period of May 1, 2016, to April 30, 2017, at a total cost not to exceed forty thousand, four hundred ninety-nine dollars (\$40,499), reimbursable at a rate of 100 percent; and

WHEREAS, this agreement has been reviewed and approved by the Health and Human Services Committee;

NOW, THEREFORE, BE IT RESOLVED that the Chairman of the Board of Supervisors be and is hereby authorized to renew an agreement on behalf of the County of Madison and Family Counseling Services of Cortland County, Inc., in the form as is on file with the Clerk of the Board.

**RESOLUTION AUTHORIZING THE CHAIRMAN TO PROCLAIM
APRIL AS ALCOHOL AWARENESS MONTH**

NCADD ALCOHOL AWARENESS MONTH 2016

“Talk Early, Talk Often: Parents Can Make a Difference in Teen Alcohol Use”

WHEREAS, alcohol is a primary factor in the four leading causes of death for young persons ages 10-21; and

WHEREAS, alcohol is the most commonly used addictive substance in the United States; and

WHEREAS, young people who begin drinking before age 15 are four times more likely to develop alcohol dependence than those who begin drinking at age 21; and

WHEREAS, the typical American will see 100,000 beer commercials before he or she turns 18; and

WHEREAS, kids who drink are more likely to be victims of violent crime, to be involved in alcohol-related traffic crashes, and to have serious school-related problems; and

WHEREAS, a supportive family environment is associated with lowered rates of alcohol use for adolescents; and

WHEREAS, consistent and sustained parental attitudes can influence a child's decision about whether or not to use alcohol and drugs; and

WHEREAS, kids who have conversations with their parents and learn a lot about the dangers of alcohol and drug use are 50% less likely to use alcohol and drugs than those who don't have such conversations.

NOW THEREFORE, BE IT RESOLVED, that we, the Madison County Board of Supervisors, join the National Council on Alcoholism and Drug Dependence, Inc. (NCADD) and hereby proclaim that April 2016 is Alcohol Awareness Month in Madison County and call upon all citizens, parents, governmental agencies, public and private institutions, businesses, hospitals, schools and colleges to support efforts that will provide early education about alcoholism and addiction and increase support for individuals and families coping with alcoholism. Through these efforts, together, we can provide Hope, Help and Healing for those in our community who are facing challenges with alcohol use and abuse.

BE IT FURTHER RESOVLED, that the Clerk of the Board duly publish a notice of said hearing in the official newspapers of the County at least five days prior to the scheduled hearing date.

COUNTY OF MADISON

A LOCAL LAW OVERRIDING TAX LEVY LIMIT ESTABLISHED IN GENERAL MUNICIPAL LAW §3-c

Be it enacted by the Madison County Board of Supervisors as follows:

Section 1. Title: This law shall be known as “A Local Law Overriding Tax Levy Limit Established in General Municipal Law §3-c”

Section 2. Legislative Findings and Purpose:

General Municipal Law §3-c “Limit upon real property tax levies by local governments” requires 60% approval from the County Legislative Body in order to increase the county tax levy from the previous year above two (2) percent or above the rate of inflation, whichever is less. This year the projection is .3 percent or less due to lower inflation numbers.

Due to the cost of State mandated programs and services the Madison County Board of Supervisors has been forced to authorize the override of the State imposed tax cap in order to have sufficient funds to protect the wellbeing of the citizens of Madison County and provide essential local public health, safety, and infrastructure programs and services.

Mandated State programs and services include but are not limited to Medicaid, Public Assistance, Child Welfare, Pre-School Special Education, Indigent Defense, Early Intervention, Youth Detention and Pension costs. These State mandated programs and services require more than Thirty Million County dollars and exceeds the total prior year’s County real property tax levy.

These State mandates must be paid first before local taxes may be used for County purposes.

Madison County can effectively implement a property tax cap only if there is a meaningful action by the State of New York to control the cost of State Mandated Programs and Services and provide mandate relief.

The purpose of this local law is to comply with the requirements of General Municipal Law §3-c prior to adopting the 2017 County Budget.

Section 3. Tax Levy Limit Override

The Board of Supervisors of the County of Madison is hereby authorized to adopt a budget for the fiscal year commencing January 1, 2017 that requires a real property tax levy in excess of the amount otherwise prescribed in General Municipal Law §3-c.

Section 4. Severability:

If any section, subsection, sentence, clause, phrase or other portion of this local law is for any reason declared unconstitutional, or invalid, or in whole or in part by any court of competent jurisdiction, such portion shall be deemed severable and such unconstitutionality or invalidity shall not affect the validity of the remaining portions of this law which shall remain in full force and effect.

Section 5. Effective Date:

This Local Law shall take effect immediately upon filing with the Secretary of State in accordance with Section 27 of the Municipal Home Rule Law.

AUTHORIZING THE EXECUTION AND DELIVERY OF AN ENERGY PERFORMANCE CONTRACT EQUIPMENT LEASE PURCHASE AGREEMENT AND RELATED DOCUMENTS, AND AUTHORIZING THE CHAIRMAN TO ENTER INTO AN MEASUREMENT AND VERIFICATION SERVICES AGREEMENT

WHEREAS, the County of Madison, New York (the “County”), has solicited requests for proposals in connection with various energy improvements in County facilities, and, as a result thereof, has selected National Grid (who is sourcing the work to SmartWatt Energy, Inc.) to undertake and perform the identified energy related improvements (the “Project”); and

WHEREAS, it is now desired to approve the financing of this Project, at a maximum estimated cost of \$2,590,240 and to authorize various actions and the execution of a lease purchase agreement with Sterling Bank (the “Lease”) in substantially the form presented at this meeting, as well as related documents; and

WHEREAS, it is necessary to enter into a Measurement and Verification Services Agreement with SmartWatt Energy, Inc. to delineate the terms of the agreement and document the guaranteed energy savings.

NOW, THEREFORE, BE IT RESOLVED AS Follows:

Section 1. The County Treasurer is authorized to execute the Lease and related escrow contract in order to finance the Project described in the preambles hereof.

Section 2. The County Treasurer and other officers of the County are hereby authorized to take all action necessary or reasonably required in order to effectuate the intent of this resolution.

Section 3. The Chairman of the Board of Supervisors is hereby authorized to enter into a Measurement and Verification Services Agreement with SmartWatt Energy, Inc. in substantially the form as is on file with the Clerk of the Board of Supervisors.

Section 4. This resolution shall take effect immediately.

RESOLUTION NO. 136-16

SUPPORTING SENATE BILL S.4964A AND ASSEMBLY BILL A.8201 BY THE NEW YORK STATE LEGISLATURE TO INCREASE THE SHARE OF REVENUE COUNTIES RETAIN FOR PROVIDING CERTAIN DMV SERVICES

WHEREAS, Fifty one of the sixty two New York State counties are mandated by the state to operate a local Department of Motor Vehicles (DMV) office; and

WHEREAS, the Madison County DMV is one of the many examples of shared services that counties provide for the state; and

WHEREAS, under current law the State of New York takes 87.3 percent of all fees collected from the work performed by the county-operated DMV transactions despite the county providing the face-to-face services, including overhead and staffing to fulfill its state-mandated obligations; and

WHEREAS, in 2015 Madison County DMV handled transactions totaling \$9,932,471 and retained \$1,017,212; and

WHEREAS, the remaining 12.7 percent on most transactions being the county share, this percentage has not been increased since 1999 and there are numerous no-retention services. In addition, NY State DMV Internet services continue to affect the amount of fee-based revenue available to county DMVs including a proposal by the State that could lead to a significant reduction in our automotive dealership business by encouraging dealers to complete transactions online; and

WHEREAS, the Governor and State Legislature have stated that lowering the property tax burden on local residents is a key priority; and

WHEREAS, increasing the county DMV revenue sharing rate with the state will not result in any increased costs or fees to local residents or taxpayers and will provide counties with revenue to continue to provide necessary mandated local government services; and

NOW, THEREFORE, BE IT RESOLVED, that the Madison County Board of Supervisors urges the New York State Senate and Assembly to approve Senate Bill S.4964A and Assembly Bill A.8201, a concurrent resolution of the New York State Assembly and Senate proposing amendments to the New York State Vehicle and Traffic Law in relation to increasing the retention percentage collected for certain motor vehicle fees; and

BE IT FURTHER RESOLVED that a copy of this resolution be forward to Governor Andrew M. Cuomo, Senator David Valesky and Assemblyman William Magee.

RESOLUTION NO. 137-16

AUTHORIZING TAXING DISTRICT GRANTS AND MODIFYING THE 2016 ADOPTED COUNTY BUDGET

WHEREAS, New York State negotiated and structured a settlement of various Oneida Indian Nation of New York (“OIN”) related litigation and contested matters, which settlement has taken the form of a Settlement Agreement among the OIN, the State of New York, the County of Madison & the County of Oneida (“Settlement Agreement”) as approved by Resolution No. 157-

13 of the Madison County Board of Supervisors on May 30, 2013, and as approved by the other parties to that Agreement, with Madison County acting pursuant to the related state legislation implementing the Settlement Agreement (Chapters 174 and 175 of the Laws of 2013, Executive Law Section 11 and Indian Law Section 16).

WHEREAS, Section V€ of the Settlement Agreement, labeled “Nation Land Not Taxable,” provides in subsections (1) and (6), in pertinent part, as follows:

(1) Without regard to whether land has been (or has not been) and is now (or is not now) exempt from property taxation or otherwise non-taxable, Nation Land shall be non-taxable, and the Nation shall not be liable to the State or any municipal subdivision of the State for any past, present or future property tax payment with regard to Nation Land, and no bill for such tax shall be issued...

(6) Notwithstanding Sections V(E)(1) and V(E)(4) of this Agreement, the Nation shall make to the Counties a payment in an amount equal to the amount of property tax that would be due from any non-Indian owner with respect to any parcel of Reacquired Land within the Cap provided in Section VI(B)(4) of this Agreement that is acquired by the Nation after the Effective Date of this Agreement and until such time as the particular land is transferred to the United States in trust for the Nation, With respect to Nation Land, the Nation’s payment shall be based on the assessed value of the parcel prior to the transaction in which it was acquired by the Nation.

WHEREAS, pursuant to such provision the County has submitted an invoice to the Oneida Indian Nation for 2015 and received payment therefor; and

WHEREAS, the full scope and effect of the Settlement Agreement remains to be determined, particularly with regard to charges relating to special districts benefiting properties directly, but at this time certain special district charges have been included in the invoice and paid by the Oneida Indian Nation; and

WHEREAS, while the Settlement Agreement provides that the County is to receive such funds, nevertheless, given the impact of the loss of revenue to the districts is significant it is the desire of this Board of Supervisors to provide a share of the County’s payments to the affected district to mitigate the impact on such district of the actual or potentially exempt status of certain properties owned by the Oneida Indian Nation; and

WHEREAS, to that end Madison County intends to make grants, namely one-time payments, more specifically as proved in the attached Schedule of Parcels and Payments.

WHEREAS, such one-time payments will be made on or about May 1, 2016; and will be intended to mitigate the above referenced period and is to be used solely to support the infrastructure of and the municipal services provided to the taxpayers of such districts;

WHEREAS, the Board does not commit to payments in future years and will evaluate the prospect of future payments.

NOW, THEREFORE BE IT RESOLVED, that the Madison County Board of Supervisors hereby authorizes the Madison County Treasurer to disburse as a grant the sums set forth and described on the attached Schedule of Parcels and Payments to each of the districts set forth therein totaling \$231,459.05; and
